See Spot Sprint LLC Service Agreement

Thank you for the opportunity to serve your pet. The following agreement pertains to the services provided by See Spot Sprint LLC.

This Agreement is made between Pet Owner(s) and See Spot Sprint LLC.

- A. Service is a 30 minute “Zoomies” session of walking, sprinting, or running on a canine treadmill for dogs 170 lbs. or less.
- B. The cost of each service is \$40 for each 30 minute session (per dog). A \$20 Deposit (per service/dog) is required upon scheduling each appointment, and it will be applied towards the \$40 service fee (per dog). The Remainder of the Payment is due upon completion of service. You agree to pay fees in the following way:
 - a. Group (three dogs or more) rates are available by calling 424.888.0432.
 - b. Deposit of \$20 (per service/dog) is to be paid upon scheduling (via Credit Card). The Remainder of \$20 (per dog) is to be paid at time of service (paid with Cash or Credit Card).
 - c. If you have questions about your choice of payment options, please do not hesitate to ask.
- C. Pet Owner(s) acknowledge that aggressive pets will not be serviced
- D. Pet Owner(s) agree that their pet is 170 lbs. or less.
- E. Pet Owner(s) understands that See Spot Sprint is not a daycare service and is only available for the reserved session time (30 minutes).
- F. First-time customers are required to attend the first session with their pet (to assess their pet’s comfort and temperament on the treadmill).
- G. Pet Owner(s) should be available to retrieve their pet 5 minutes before the end of their session.
- H. Pet Owner(s) understands that, for health reasons, their pet **should not eat less than 2 – 4 hours before each session.**
- I. Pet Owner(s) understands that, for health reasons, they **should wait at least 1 hour after each session before feeding their pet.**
- J. Pet Owner(s) authorizes See Spot Sprint to obtain emergency veterinary care for pet as/when necessary. In the case of an emergency See Spot sprint will contact Pet Owner(s) at the number provided on the Veterinary Release Form. If Pet Owner(s) cannot be reached in a timely manner, See Spot Sprint is authorized to:
 - a. Request on-site treatment from a veterinarian;
 - b. Transport the pet to an emergency clinic if the other option is not available.
- K. Pet Owner(s) understands the Cancellation Policy:
 - a. Sessions should be cancelled/rescheduled more than 48 hours before appointed session.
 - b. Sessions cancelled/rescheduled less than 48 hours before the appointed session will be charged a \$20 fee.
 - c. Sessions cancelled/rescheduled less than 24 hours before the appointed session will be charged the full price of \$40.
